Important Notice: Application of K-REACH Tonnage Coverage Certificate

It shall be noted that CIRS, as Only Representative, shall maintain the list of importers and keep up-to-date information on quantities imported under K-REACH. When appointing an Only Representative, it is necessary that the "non-Korean manufacturer" provides his only representative with up-to-date information on the list of Korean importers who are to be covered by the registration of the Only Representative and the quantities imported into the Korea.

Shandong Longgang Silicon Technology Co. Ltd shall inform CIRS of the importers in Korea and the quantities imported by applying for a K-REACH tonnage coverage certificate from CIRS.

It is also recommended that the importers get their chemical substances certified by applying for K-REACH Tonnage Coverage Certificate for their imports from CIRS free of charge. The certificate guarantees that the tonnage of imported chemical substances are covered by the registration(s) of CIRS Group Korea Co., Ltd. (OR) and the importers will be regarded as downstream users (DU) who do not need to submit their own K-REACH registration(s).
